## **Guide Lines for Bank Guarantee preparation:**

- 1. Bank Guarantee has to be made on Non Judicial stamp paper from any nationalized bank.
- 2. Bank authorities will give BG Number and will sign on each page. Minimum two Bank official signatories, who are authorized to sign, will sign the Bank Guarantee.
- 3. Bank authorities will forward the BG to American International Institute of Medical Sciences, Udaipur under a proper covering letter.
- 4. In case of any deviation from above, BG will not be accepted.
